WELCOME TO MARKETPLACE 2018

We are delighted to welcome you to the 37th annual MARKETPLACE conference. Each year, the Governor's Conference on Minority Business Development provides an opportunity to celebrate Wisconsin's minority, women and veteran-owned businesses, as well as connecting these businesses with new opportunities through networking, buyer meetings and workshops.

The diversity of our state's business community is a valuable asset, and MARKETPLACE showcases that diversity. Whatever role you play in this one-of-a-kind event, I would encourage you to explore all of its facets this year, and discover the immense possibilities for learning and making connections over these two days.

The Wisconsin Economic Development Corporation (WEDC) works year-round to enhance the environment for minority, women and veteran-owned businesses in Wisconsin. During fiscal year 2018 (FY18), WEDC awarded \$750,000 to four partner organizations to provide assistance to minority-owned businesses throughout the state. These organizations—the African American Chamber of Commerce of Wisconsin, the American Indian Chamber of Commerce of Wisconsin, the Hispanic Chamber of Commerce of Wisconsin and the Hmong Wisconsin Chamber of Commerce—were officially named Key Strategic Partners of WEDC. This designation recognizes their specialized skills and proven track record of success, as well as their valuable contribution to the state's economic development outcomes.

Also during FY18, the \$700,000 in revolving loan funds that originated from WEDC in prior years generated an additional \$3.7 million in funding from other sources. The projects funded by these loans and the additional funds leveraged are expected to result in the creation or retention of more than 200 jobs at minority-owned small businesses. During FY18, these Key Strategic Partners and their six affiliate organizations provided services to 338 businesses around the state and conducted 48 workshops on business development topics. MARKETPLACE is the culmination of these efforts that take place throughout the year to help minority, women and veteran-owned businesses succeed.

By the time MARKETPLACE concludes, dozens of businesses will have been recognized for their accomplishments and their contributions to the community. Hundreds of buyer meetings will have been held, with connections that will continue to bear fruit in the coming months and years. But the event metrics do not capture the hundreds of conversations that take place at the breakfast, lunch and reception, and in the corridors outside of the official schedule.

We are extremely grateful to the event sponsors and the businesses and organizations that have purchased space in the Expo Hall, as well as our network of statewide partners. Neither this event nor the broader task of serving these business communities are tasks we could accomplish on our own. I would like to take this opportunity to thank our partners, sponsors, supporters and attendees of the main conference as well as the Small Business Academy. Each of you plays a key part in making this event the success it is.

Most of all, thank you to the businesses for the enthusiasm and entrepreneurial spirit you bring to this event and to helping move Wisconsin's economy forward.

BREAKFAST SPEAKERS

This year, three small businesses will share their insights on how MARKETPLACE, business certifications and resources help them start and grow their businesses.

Craig Dretzka, President UPI LLC

Craig Dretzka was born and raised in West Allis, WI, by his parents, Bonnita and Leo Dretzka. By age 12 he could often be found on job sites run by his dad's small business, Leo Dretzka Construction. Common duties included landscaping and general labor. While he was growing up, it was not uncommon for Craig to be operating heavy equipment and helping with sewer and plumbing installation. Every summer and winter break during high school and college was spent learning the trade by working on job sites.

Craig attended the University of Wisconsin-Madison, where he earned a degree in business. After graduation, Craig moved to California and began work for Toyota Motor Corporation in various disciplines, including marketing and manufacturing. In California, Craig married his wife, Kris. After his mother passed away, Craig and Kris returned home and Craig began working for his brother's construction business. After six years of estimating and project management, Craig followed his desire to test his abilities in sales as a manufacturer's representative.

Kristina Pence-Dunow, CEO Hometown Trolley

Kristina Pence-Dunow, CEO and owner of Hometown Trolley, founded the corporation in 1992 in the small town of Crandon, Wisconsin. Hometown Trolley, a transit vehicle manufacturer (TVM), builds trolley buses for public and private transportation, delivering to locations across the U.S. and abroad. Kristina focused on keeping the company stable while raising her children for the past 26 years. Recent growth in the past five years has quadrupled the size of the company. Hometown Trolley is the nation's only woman-owned TVM and is a certified disadvantaged business. Named 2017 Small Business Person of the Year by the U.S. Small Business Administration, Kristina has strived to grow her company and brand to compete with manufacturers 10 times her size, while maintaining a high-quality product with a solid base of repeat customers. Kristina attributes the growth and success of her company to maintaining a personal connection with her employees and customers.

Darren Fisher, Owner SPEARity

Darren Fisher started SPEARity, formerly Darren Fisher Consulting, in 2010 as CEO and lead strategist. He is the author of the best-seller *The Confidence Quadrant* and is an international motivational speaker. Darren is also an Air Force veteran who received accolades for outstanding service, leadership and technical ability. Darren fundamentally believes there's excellence in everyone, so he's made it his mission to help others achieve greater success. Darren holds a bachelor's degree from Marquette University and a master's degree in computer science education from Cardinal Stritch University.

STATE DIVERSITY DEVELOPMENT AND ADVOCACY



Aggo Akyea served as the director of the Office of Business Opportunity and Equity Compliance at the Wisconsin Department of Transportation (WisDOT) central office in Madison from 2011 to 2018. The office serves as WisDOT's regulatory arm, working specifically to promote business opportunity, equity and compliance in the areas of the Disadvantaged Business Enterprises (DBE) Program, labor and wage compliance, Title VI, the Americans with Disabilities Act (ADA), and tribal affairs.

Aggo started his state career in 1989 by working for Madison Area Technical College (MATC) as assistant manager and federal procurement specialist. In 1991, he joined the Department of Commerce Bureau of Minority Business Development as the marketing and certification consultant. During his 14-year tenure in this position, Aggo used his procurement expertise and implemented a very efficient state certification process for certifying minority-owned

businesses, and was responsible for certifying hundreds of minority-owned businesses to do business with the state. As part of his marketing duty, he was responsible for producing MARKETPLACE: the Governor's Conference on Minority Business Development, and was known as the "MARKETPLACE guru." In 2006, Aggo was hired by WisDOT as minority business enterprise program specialist to help establish the newly created office that identified contract opportunities to help the department meet the state's goal in doing business with minority-owned businesses. Aggo returned to the Department of Commerce and led the Bureau of Minority Business Development as director from 2008 to 2011. Aggo was President of African Association of Madison, (AAM) Inc. a non-profit that serves African descent and friends of Africa; chair of AFRICA FEST and Adjunct Professor at MATC. Aggo holds MBA in Finance & Management from St John's University, New York; DipMGT from Holland and BS in Economics & Sociology, University of Ghana.

MENTORING SMALL BUSINESS IN GOVERNMENT CONTRACTING AWARD



Aina Vilumsons – Wisconsin Procurement Institute

Aina Vilumsons is the CEO of the Wisconsin Procurement Institute (WPI), a nonprofit established in 1987 that evolved from then-U.S. Congressman Les Aspin's efforts to help Wisconsin businesses win federal contracts. As one of the first Procurement Technical Assistance Centers (PTACs) in the nation, the Wisconsin Procurement Institute was focused on helping Wisconsin businesses compete for federal defense contracts. After joining WPI in 1997, Aina began expanding business mentoring and assistance services to also encompass local, state and corporate supplier contracting opportunities.

Under Aina's leadership, the organization's strategy has focused on building a statewide team of procurement experts with extensive career experience in government contracting and industry. With this strong technical capability giving them a firsthand understanding of government market processes and business opportunities, the statewide team assists businesses with designing and executing a strategic approach to

entering the public market. This includes providing individualized assistance, identifying contracting opportunities, training for using online government procurement portals, helping businesses complete contractor registrations and certifications, educating on post-award compliance requirements, preparing and reviewing proposals, and offering matchmaking opportunities. Each year more than 1,000 Wisconsin businesses benefit from the mentoring provided by WPI's team of experts.

Gary Mejchar has been serving as the assistant director and project manager for the First American Capital Corporation of the American Indian Chamber of Commerce of Wisconsin (AICCW-FACC) since 2008. Gary obtained his master's degree, focusing on community economic development, from the University of Wisconsin-Madison. Gary's over-15-year career in state government began as a project manager with the UW-Extension Community Dynamics Institute. He went on to become director of the newly established Wisconsin American Indian Economic Development Program that was a statewide Native American Small Business Development Center (SBDC). Following his work with the SBDC, he became a project management consultant assisting Wisconsin tribal enterprises, programs and colleges with sustainable business and economic development initiatives.

In his current roles, Gary applies his extensive experience and relationships in community and economic development to identify new and collaborative approaches to assisting Native and minority businesses. An expert in grant writing, he has secured hundreds of thousands of public and private funds, and recently he was instrumental in obtaining a \$250,000 Wells Fargo grant by working with the Hmong Wisconsin Chamber of Commerce (HWCC). Together, they developed an innovative proposal to fund shared staff and resources. This strategy enables both community development financial institutions (CDFIs) to grow their small business lending portfolios while more cost effectively increasing the level of technical assistance for underserved populations statewide. Gary has collaborated with three other certified Native CDFIs in Wisconsin in the formation of the Wisconsin Indian Business Alliance (WIBA)

Nelson Soler – Multicultural Entrepreneurial Institute

Nelson Soler is chief solutions officer of the Multicultural Entrepreneurial Institute, which he founded in 2006 out of his basement. He holds master's degrees in business administration, in international business and in marketing from the University of Wisconsin-Milwaukee, and bachelor's degrees in both electrical engineering and economics from the State University of New York.

Nelson has a diverse range of experience in banking, international business, manufacturing and real estate. He also is an accomplished educator with decades of teaching experience in higher education classrooms, business training sessions and business conference seminars. Nelson is an innovative entrepreneur who has founded two for-profit and three nonprofit organizations. As a founder and collaborator of Latino Entrepreneurial Network Inc., Nelson runs the bilingual business boot camps that train small business owners in how to grow their businesses.

Through these organizations and Nelson's personal dedication to helping others, over 3,000 entrepreneurs have been assisted in realizing their business ideas and ownership dreams in southeast Wisconsin. Currently, the Institute serves an average of 450 individuals per year through culturally relevant training, tax services and marketing. The Milwaukee-based institute, which employs four people, has been recognized with multiple national and state awards.

Nelson's involvements include: Commissioner in the Milwaukee Fire and Police Commission; Founder of the LEN LULAC Chapter; and Advisory Council Member for Wisconsin Bank and Trust; Member; Hmong Wisconsin Chamber of Commerce; Member, African American Chamber; and Greater Milwaukee Association of Realtors.

MINORITY BUSINESS COMMUNITY SERVICE AWARD



Curtiss Harris - Business Partners Network LLC

For over four decades, Curtiss Harris has advocated for equal access for minority-owned businesses in the Milwaukee area. His work in community and economic development began in 1966 while working at the Boston Store as a research director. Seeing the need for the black community to grow through economic development opportunities versus social services processes, he gained Boston Store's permission to work on minority-owned business development activities during office hours.

This began a lifetime of community and economic development service that forged partnerships and made lasting impact in both the private and public sectors. As a City of Milwaukee economic development coordinator working on the Model Cities Program in the 1970s, Curtiss helped coordinate the original design and structure for

the Milwaukee Economic Development Corporation. In 1978, he became the executive director of the Milwaukee Community Development Corporation, where he counseled and assisted hundreds of minority-owned small businesses for over a decade. In his first private consulting practice, Business Opportunity Associates, he helped minority-owned firms participate on multimillion-dollar developments including office and condo projects, airport expansions, convention center developments, the Miller Park baseball stadium, and Camp Randall and the Kohl Center in Madison. Because of his relationships within Milwaukee's community, Curtiss was called on to serve as the interim executive director of the African American Chamber of Commerce of Wisconsin and as the interim chief of staff for the City of Milwaukee. More recently, in 2015, he teamed up with his daughter to launch the online business directory mkeblackbusiness.com to link consumers with black-owned businesses in the Milwaukee area.

Curtiss attended Milwaukee Public Schools, graduated from North Division High School, and studied engineering and business at the University of Wisconsin-Milwaukee, where he graduated with a bachelor's degree in business.

Maria Watts Maria Watts is a senior business and community engagement officer for the Wisconsin Housing and Economic Development Authority (WHEDA). As a passionate and tireless business and community advocate, Maria works to help hundreds of public and private entities leverage WHEDA's knowledge, resources and programs. She is an enthusiastic team member of WHEDA's Transform Milwaukee Initiative, which brings together Milwaukee's workforce, industrial and transportation assets to restore economic vitality in Milwaukee's industrial corridors and surrounding neighborhoods.

Prior to her career with WHEDA, Maria was a housing coordinator for La Casa de Esperanza and an assistant vice president for Tri-City National Bank. She earned her bachelor of science in accounting from the University of Coahuila and has served on numerous boards of directors over the past 20 years. Maria is currently the chair of

UMOS, which is a national nonprofit advocacy organization providing services to improve the employment, educational, health and housing opportunities of underserved populations. She also serves on the Wisconsin Women's Business Initiative Corporation (WWBIC) Loan Committee and is a board member of the Waukesha County Home Board, BizStarts and the Local Initiatives Support Corporation (LISC).

Maria generously shares her decades of experience and connections to build collaborative environments that connect public, private and nonprofit organizations in ways that expand community investments, increase business development, boost job creation and strengthen neighborhoods.


